
- Capacity Building and Empowerment: Programs improved skills in ecotourism management and conservation.

However, gaps in accessibility and inclusivity often limit the effectiveness of training programs. Programs designed with culturally sensitive and inclusive approaches, such as incorporating traditional knowledge and accommodating diverse learning needs, have demonstrated higher success rates.


